The Treasurer has continued the simplified the accounts and ceased accruing capitation on a prepayment/accrual basis and accounted for the amounts "real time".

Capitation for 2013/2014 has not been paid in this financial year though capitation fees have been received from some, not all, groups.

Payment of Capitation to County is not due until 11th April 2014 and the payment cheque was post dated with the approval of County, post dated.

The payment due to paid in the next financial year is -----:: £24,024.00 All but one group (Scorpions) paid capitation on time and will get credits back.

Funds available should the Capitation cheque be cashed early = £42,688.65

Valuation of the Garners field site buildings etc. was been carried out by Unity Insurance underwriters in 2013 and the site is was valued at £357,000 for full re-building purposes. No valuation has been taken for this financial year though the site will have appreciated.

There are £404 worth of cheques written that have not been cashed yet from last year. There is also £792.57 of presented cheques from 2012/13 for Madcats in the accounts.
