Accounting Practice/Procedures. The treasurer has now completed the simplification of the accounting procedures for the district and we are now totally moved to an "Income/Expenses" basis, recording transactions on the day/date that they occur. This also falls into line with the procedures adopted by County.

Valuation of the Garners field site buildings etc. has remained static from last year we will seek to get a insurance valuation of the site for the next years accounts.

No valuation has been taken for this financial year though the site will have appreciated.

There are £2543.60 of cheques un-presented and un-cashed.

There was no family camp in this financial year so no funds were received from this event.

The large spend on the Campsite represents the road resurfacing, costing over £30,000. However some of this cost was offset by a donation/contribution of £6,000 from the Guides. The balance was paid out of District funds.

Both the shop and the Campsite have contributed to total district funds to the total transfer value of £20,000, proving how valuable they both are as assets to the district.

Substantial reductions, nearly half, in insurance fees have been realised by moving both the District/Campsite and the shop away form Unity Insurance to the Salvation Army Insurance Company.

The Campsite has been burgled several times and equipment stolen. The new insurance policy has re-imbursed us for over £1,300 of stolen equipment. We have also invested in new security equipment at the Campsite and an alarm system, costing £1,700.
