### Notes:

Valuation of the Garners Field site buildings etc. has been increased to £637,886 as this is the insured values from the Salvation Army Insurance Group.

The Family Camp took place again in 2019 and was a huge success as usual bringing to the District extra valuable income, as well as being a fun, friendly and exciting event. The pop up cafe, serving food most of the day was much enhance this year and also was a huge success, raising over £2,000 for the District.

Both the shop and the Campsite have contributed to total District funds to the total transfer value of £26,000, proving how valuable they both are as assets to the District.

The greatly enhanced Activity Centre at Garners Field, just about completed after the beginning of the financial year, has proven a great attraction to campsite visitors. The new facilities have helped make mania a camper happy with the site and as usual we attracted many visitors and campers from other youth groups during the year.

A NEW online booking system for the campsite has allowed more automation, complete with an on line booking calendar so potential visitors can see the availability of the camp.

A decision was reached, just before the accounting year end, to streamline further the accounts for the District by "merging" the Campsite account with those of District itself. As the District now uses an online accounting system, campsite booking invoices can be generated centrally and managed by both the treasurer and the campsite manager.

The District has reserve funds on deposit of just over £17,000, which is showing on the Capital Statement. This has been maintained at approximately the same level as at the last year end and is despite high expenditure on the Garners Field refurbishment project.

Unfortunately, just prior to the year end the UK was struck with the Covid-19 pandemic and the UK was placed in "Lockdown". This has meant that all bookings for the Family Camp for April 2020 had to be cancelled and refunded to all people planning to come. The refunds totalled some £2,600 and of course this will effect revenue in the forthcoming year, for this event alone, to the tune of approx. £7,000. Also campsite bookings will be affected in the coming year due
